Minimum Requirements

Client agrees to provide Alaska Rider Tours with proof of some or all of the following:

- (a) Client is at least 21 years of age (if 21 years of age, rider must be accompanied by guardian); and
- (b) has at least 3 years riding experience with a 650 cc motorcycle or higher; and
- (c) has an International Driver license with MC endorsement; or
- (d) Client possesses a valid drivers license containing a motorcycle endorsement from his/her home state or country; and
- (e) Customer possesses a major credit card.(\$1,000 damage deposit required for all rentals)

*Contract: Client agrees to pay Lessor upon demand all charges incurred in the connection with the rental described herein, including all rates, option charges, participation in any violation of law with regard to the owner to pay the amount incurred by Lessor, refueling service charges, airport fees, taxes and other charges, plus all loss of or damage or other personal claims. Client further agrees to pay all costs of collection of amounts due under this contract, including attorneys fees, vehicle loss of use, plus a reasonable administrative charge. Client agrees to be personally responsible for all charges if another party is billed for the rental but fails to timely pay the charges. Client authorizes Lessor to reserve credit with the credit card issuer in an amount equal to all estimated charges and to bill the Clients credit card for all charges for a period of one year after execution of the Rental Contract. Client understands that all charges are subject to final audit and authorizes Lessor to make the applicable credit or charge by the method used at the time of rental or return and authorizes Lessor to apply to the credit card fees all charges. Unlocked Motorcycle: Any motorcycle that is left unlocked will not be insured for theft and the value of the motorcycle or any future loss of profit on the motorcycle, cost of recovery and damages shall be borne by the operator.

Liability Insurance: In the event that any provision of this Rental Agreement is violated or breached, the right of the Client to use, operate or drive such vehicle shall be void and terminate immediately, and Client shall be fully liable for the entire amount of all damages of every kind both to the rented vehicle and to other persons or property.

Protection of Motorcycle: When not in use, Bike shall be locked. Bike shall be placed in a secure area if the bike is going to be left alone for any prolonged period of time.

Protective Clothing: Rider and passenger shall wear eye protection and gloves in all operations of the motorcycle. Additional protective clothing is not required, but it is highly suggested and recommended that it be worn for the Clients own protection.

Helmets: Alaska law does not require helmets, but this lease requires the lessee to provide its own DOT approved helmets or the lessor shall have available to lessee DOT approved helmets. ***Indemnification:** Customer hereby further agrees to indemnify and hold harmless Lessor of and from any and all damages, including attorneys fees and court costs, by reason of any claim of or by any person or entity as a consequence of personal injury or property damage or both. **Damages:** Client agrees that Lessor is not responsible for such unforeseen and uncontrollable mishaps such as flat tires from nails or other road debris. In the event of a breakdown the Client shall immediately notify Lessor. Client is responsible for checking engine oil and fluid levels at each refueling as well as reporting mechanical failures to Lessor immediately. Customer is responsible for mechanical damage due to negligence in vehicle operation.

Hold Harmless: Client covenants and agrees with Lessor that he/she will forever hold harmless and indemnify said Lessor from any and all claims, demands, causes of action, attorneys fees and expenses of any nature arising or alleged to arise from the use, operation and maintenance of the motorcycle while this contract remains in force and effect, and to reimburse Lessor for any loss or damage during said Period. Client further agrees that in the event Lessor files any action or demand for arbitration to recover possession of or the value of or the cost of repairing said motorcycle, or in the event Lessor employs an attorney to defend it in any action filed by Client, or anyone claiming for loss or damages arising out of the use of the motorcycle while in the actual or constructive possession of Client, Client agrees to pay to Lessor the actual amounts expended for attorneys fees and costs.

Client agrees to pay the rental rate, and other charges shown on the front. The minimum charge is one day. A rental day is based upon the number of nights the vehicle is used. Each night constitutes a rental day. Client agrees that all charges, fees and expenses, including payment for loss of or damage to the motorcycle are due at Lessors request and Client assigns to Lessor any and all proceeds from coverage under credit card plans or other insurance. Client shall pay any collection costs, including, but not limited to the actual amounts expended by Lessor for attorney's fees and costs.

Authorized Use of Credit Card: Client authorizes Lessor to charge Clients credit card for the security deposit set forth in this Contract, for any rental charges unpaid at time of pickup, for any additional charges upon return of the motorcycle, and for the repair for any damage to the motorcycle, for the cost of lost service to the motorcycle if repair is needed, related expenses, and administrative fees, and the Client authorizes the Lessor to make these charges against the credit card given to the Lessor up to a period of one year from the date of execution of this contract. If, for any reason, the credit card does not cover the total amount of these expenses, the Client agrees to pay immediately upon being billed for these services. If Client is overcharged or undercharged, Lessor may charge or credit Clients credit card.

Client represents that he/she is now duly authorized to operate a motorcycle.

I have fully read this paragraph, I have had the opportunity to ask questions regarding this paragraph and I agree with the terms of this paragraph.

I have read and agree to abide by the terms of the Cancellation Policy.

Cancellations must by received in writing and are refunded on prorated bases as follows: 60 days Prior to arrival a \$75 Cancellation Fee is charged, 30 days Prior – 75% of Rental Fee is refunded. 14 Days Prior 50% of Rental Fee is Refunded: 7 Days Prior 25% of Rental Fee refunded: less than 7 DAYS notice – please contact me.
